## **Introduction**

The CLEEN Foundation (formerly known as Centre for Law Enforcement Education) is a non- governmental organization established in January 1998 with the mission of promoting public safety, security and accessible justice through the strategies of empirical research, legislative advocacy, demonstration programmes and publications, in partnership with government, civil society and the private sector. CLEEN with the support of MacArthur Foundation is presently executing a project aimed at digitalizing courts proceedings in Nigeria with a view to promoting accountability and transparency in the fight against corruption. The project also monitors cases of corruption vis a`vis the implementation of the ACJA 2015 through a web-based platform. The project's goals seeks to make information on corruption and accountability easily accessible (online and offline) to legal practitioners, law enforcement agencies, Judges, Prosecutors, Defendants, government agencies responsible for the administration of criminal justice and civil society organizations working for justice sector reforms, legal scholars and researchers. - 3) To oversee the coordination of the tasks listed above.

## **Deliverables:**

Air jingles in a radio station in 8 focal states of the project for 8 weeks.

- Live radio appearance program to discuss Administration of Criminal Justice Act 2015 / ACJL in a radio talk show across the Eight (8) focal States of the project **FCT, Lagos, Oyo, Ondo, Ekiti, Enugu, Anambra and Kaduna States** for 8 weeks.
- Record and document all appearances, airing and submit same to CLEEN  
CLEEN Foundation and state partners will Identify and invite resource persons to appear on the program throughout the program period

- Experience in producing campaign jingles for both radio and television
