

CALL FOR EXPRESSION OF INTEREST FOR THE SUPPLY OF HAND SANITIZERS AND FACE MASKS

The CLEEN Foundation (formerly known as Centre for Law Enforcement Education in Nigeria) was established in 1998 as a leading non-governmental organization (NGO) to promote public safety, security, justice, research, and advocacy in Nigeria. CLEEN Foundation has Observer Status with the African Commission on Human and Peoples Rights based in Banjul, The Gambia and was awarded the 2019 Human Rights Award by the National Human Rights Commission in December 2019.

Project Background

The project is aimed at digitalizing courts proceedings in Nigeria with a view to promoting accountability and transparency in the fight against corruption. The Project monitors cases of corruption in relation to the ACJA 2015 through a web-based platform that is functional, accessible and makes contents easily available to the public. The overall goal of the project is to contribute to reducing corruption, promote judicial transparency in processing anti-corruption cases; and enhance accountability in the criminal justice system in Nigeria.

The novel corona virus disease (Covid-19) pandemic is a global disruption with unprecedented health and security implications. Although, the social, political and economic constraints of covid-19 pandemic are still emerging in Nigeria, available evidence suggests that the impact of the corona virus crisis on social and economic cannot be overemphasized.

As a leading organization on public safety and security in Nigeria, Towards meeting CLEEN's mandate on public safety and security, the organization is inviting suitable vendors to submit expression of interest for the supply of Personnel Protective Equipment towards our support to the implementing partners across the focal states of the project i.e. **FCT, Lagos, Ekiti, Ondo, Oyo, Kaduna, Enugu and Anambra State** to enable them carry out project activities.

The specific materials to be supplied are **hand sanitizers, face masks and hand wash sanitol**. Thus, through a competitive bidding process, CLEEN Foundation will review, shortlist and contract suitable vendor(s) to undertake the task.

1. Item(s) to be supplied:

- a. 500ml and 250 ml alcohol based hand sanitizers produced with strict compliance to basic chemical contents as stipulated by NCDC, NAFDAC and the Standards Organization of Nigeria. Quantity **450 pieces**
- b. Breathable Cloth Face Masks produced in compliance with the guidelines stipulated by the NCDC and Standard Organization of Nigeria - Quantity **900 pieces**
- c. 500ml Hand Wash Sanitol **440 pieces**

2. Requirements for vendors: Samples of previous delivery with reputable public and private organizations
3. Evidence of regional spread across the 8 focal states of the project - **FCT, Lagos, Ekiti, Ondo, Oyo, Kaduna, Enugu and Anambra State** of potential vendors across Nigeria.
