## **EXPRESSION OF INTEREST FOR CREATION OF CARTOON ANIMATION ON ACJA 2015**

### **Background**

The passage of the new Administration of Criminal Justice Act (ACJA) in Nigeria in 2015, significantly now alters the environment within which criminal justice would be administered in Nigeria as well as how criminal justice actors - Police, Lawyers, Directorate of Public Prosecution (DPP), Judges, Courts and Anti-corruption agencies operate. Through the innovative provisions in the Act which clarify the roles of criminal justice institutions/agencies and sets options for strategic collaboration and coordination, the new Act, if properly implemented is expected to raise efficiency in the criminal justice procedure in Nigeria.

Despite the passage of the Act since 2015 there still remains, the gamut of challenges affecting the administration of criminal justice process and justice system in general. It is against this background that this project was conceived to continue to strengthen accountability and transparency in the criminal justice system in Nigeria through sustained advocacy and monitoring of the implementation of Administration of Criminal Justice Act (ACJA), 2015. Amongst other key activities to be carried out under the project is the need to enhance public awareness on the provisions and implementation of the ACJA through development of informative and Educative materials as well as documentaries spotlighting critical criminal justice issues.

### **Overall Objective of the Consultancy**

To produce Four (4) 3D cartoon animations in drama form spotlighting innovative provisions of ACJA:-

### **Aim of the Cartoon Animations**

1. Creating public awareness on the innovative provisions and bridging the knowledge gap amongst criminal justice actors on their roles and responsibilities under the ACJA/ACJL. The animations must project that for the law to be effectively implemented, actors need to understand the law and their roles as lack of their knowledge and understanding is contributing to the continued violations of their relevant roles and responsibilities and lack of competence of the actors
2. Building/deepening the synergy amongst criminal justice actors for effective implementation of the ACJA/ACJL across the states
3. Reducing congestion of prisons by promoting non- custodial alternatives to sentencing specifically the use of community service as provided in the ACJA 2015

### **Deliverables/Outputs:**

Develop draft 5 minutes scripts on the innovative provision of ACJA 2015 to be produce in cartoon drama formats

- Produce 5 minutes cartoon animations in drama form in two major languages (English/Pidgin)
- Placement of the 5 minutes Cartoon Ads in drama form on innovative provisions of ACJA 2015 on TV/Facebook for 4 weeks i.e. 1 episode per week
- Submit all the cartoon video rushes and necessary materials
- Develop Four (4) final 3D Cartoon Animations in a cinematic format to be submitted to CLEEN within a month
- Document all placements and submit to CLEEN Foundation.

### **Required Expertise**

The vendor required to undertake the assignment must have;

- Extensive practical knowledge and experience in producing and editing 3D cartoons for television and cinema
- Good knowledge of the Administration of Criminal Justice System and law in Nigeria.
