The CLEEN Foundation (formerly known as Centre for Law Enforcement Education) is a non-governmental organization established in January 1998 with the mission of promoting public safety, security, and accessible justice through the strategies of empirical research, legislative advocacy, demonstration programmes and publications, in partnership with government, civil society and the private sector.

BACKGROUND

CLEEN Foundation contributes appreciably to decrease levels of judicial sector corruption in Nigeria and to increase accountability and transparency in the system through the sustenance, consolidation and replication of the gains of her past project(s) under the 1.0 ON Nigeria programme. Specifically, we seek to enhance and deepen the tools developed and initiated under our previous project for improving accountability and transparency in Nigeria's criminal justice system which was highlighted as necessary in the end of project evaluation report; scale up our interventions to new states (Edo, Delta, Bauchi, Sokoto, Katsina, Jigawa, Kwara and Cross River states respectively); continue to deepen the data collection process on the administration of criminal justice that was initiated under previous projects and build the capacity of other criminal justice actors for positive impact on the criminal justice system. Reflecting on the gains of our past interventions implemented in eight states namely Oyo, Ondo, Ekiti, Lagos, Kaduna, Anambra, Enugu & the FCT, Abuja, evidenced through improved inter-agency collaboration among key criminal justice actors and the use of information technology in the mitigation of corruption in Nigeria, CLEEN is inspired to commit to greater work in the area of knowledge production and dissemination in the application of Administration of Criminal Justice legislations(ACJA/ACJL) in the prosecution of corruption cases and working with key partners to enhance implementation of the laws through compliance, innovation and professionalism.

OBJECTIVES

Deepening judicial sector transparency and accountability as it concerns Politically Exposed Persons (PEPs) in Nigeria has been an area of interest for CLEEN Foundation and thus the primary objective of this study is to enunciate the compliance level of relevant actors in the implementation of the Administration of Criminal Justice Act, 2015. The specific objectives of this study are to;

- Explore the opinion of actors on the challenges associated with the implementation of the ACJA on cases involving Politically Exposed Persons (PEPs) in the focal states.
- 2. Enumerate actors' opinion on the level of compliance from all implementing partners of the Administration of Criminal Justice Act, 2015.
- Explore strategies of improving compliance of the ACJA 2015 by all implementing partners. Qualitative data will be collected 3. from the focal states.
