



# CALL FOR EXPRESSION OF INTEREST TO DESIGN, DEVELOP AND HOST WEBSITE AND MOBILE APPLICATION FOR THE E-PARLIAMENT ON CONSTITUENCY SECURITY GOVERNANCE AND PUBLIC SAFETY PROJECT

Introduction: The CLEEN Foundation (formerly known as Centre for Law Enforcement Education) is a non-governmental organization established in January 1998 with the mission of promoting public safety, security, and accessible justice through empirical research, legislative advocacy, demonstration programs, and publications, in partnership with government, civil society and the private sector.

## Background

Several nations around the world have embraced e-parliament to bring their parliaments closer to their constituents with varying degrees and have different levels of success. The Republic of Korea has adopted the use of mobile applications for parliament to operate a smart e-parliament that promotes participation, openness and efficiency. The Korean parliaments have access to applications that provide support to bill deliberation, research analysis and promotion of legislative activities. Similarly, Greece has adopted "Vouliwatch", Brazil has designed "e-democracia" while the United Kingdom operates "What Do They Know and Alaveteli" as platforms to promote dialogue between citizens and parliamentarians and enhance the relationship between citizens and their representatives. These platforms offer citizens access to their representatives' profiles and provide opportunities to communicate, evaluate and hold their representatives accountable. Citizens are also able to keep track of legislative initiatives and debate solutions to policy problems. Over time, African countries like South Africa, Zambia, Rwanda, and Zimbabwe have given their legislatures online presence and have adopted the internet for providing information on the legislature's activities. Parliamentarians are an important stakeholder in every democracy and thus e-parliament platforms increase the participation of the citizens they represent and also provide the opportunity for electorates to share areas of daily life worthy of legislation in a bid to ensure that the dividends of democracy are available to all.

## Scope of work

Working under the supervision of the IT Team of CLEEN Foundation to "DESIGN, DEVELOP & HOST" the following platforms:

- Design the website and mobile app user interface (wireframing);
- User-friendly and secure mobile application;
- Develop the website and mobile app for the e-parliament constituency platform for CLEEN;
- Host the mobile app on the private Cloud hosting plan, Google Play Store, and Apple Store;
- Produce a short video on the usability of the website and mobile app;
- Code with documentation would be submitted;

- Feeds on security governance issues within the constituency (36states and FCT, Abuja)
- Infographics on the submitted data.
- Comment/feedback addons
- User and GPS Integration
- Multimedia (photos, videos, voice recordings) components
- Data Synchronization

- User Management dashboard
- Web and mobile apps that can engage both-way traffic users on security matters.
- Design a Mobile app with the ability to collect and manage public safety and security-related data.

## Requirements

- Interested firms must possess at least 3 years of experience in website and mobile app development;
- Must possess deep knowledge and experience in designing Android and IOS apps;
- Must possess unique info-graphics data analytic skills including visualization
- Vendors must demonstrate local intelligence and be registered in Nigeria.
