







INEC and CLEEN Foundation Edo kicked off Voter education exercise in some Local Government Areas

ontinuous Voter Registration (CVR) is a system for the registration of citizens who turned 18 after the last registration exercise or those within the legal voting age who did not register in the previous exercises. The Independent National Electoral Commission collaborated with CLEEN Foundation Edo regional office on Voter education and advocacy. CLEEN was tasked to cover Continuous Voters Registration and Civil Education in one (1) of the three (3) Senatorial districts in Edo State. Locals were receptive and willing to participate in the CVR process. It was also an opportunity for people with transfer requests and/or defaced cards to get replacements. In the end, the team was able to mobilise and direct the locals to various registration centres, with impressive feedback. Click here to read more

be willing to call on our mediators to attend to some of the cases reported, putting their skills to action.





Virtual Dialogue to Examine Frameworks and Procedure for Custodial and Non-Custodial Sentencing in Nigeria's Criminal Justice System



he long-standing issue of Imprisonment while awaiting trial has been around for a while with the governments' feedback not so encouraging. Our conversations on this dialogue were to bring to light the approach in Nigeria's correctional system and to push for more "conventional" or "non-custodial" techniques to addressing them. In our Executive Director's words, "The Criminal Justice System is the cornerstone for societal governance."

Our Lead presenter, Barr Sulayman Kuku-Dawodu, who was also the secretary of the Administration of Criminal Justice Monitoring Committee, spoke extensively on the need for interventions needs to be done around the provision of Restorative justice at the sub-national levels. Non-custodial interventions like community service, vocational/psychological support and drug testing should be considered as these further reduce the issues such as prison overcrowding, impediment of education and career, long term health and

psychological problems.



Aformer Chief Magistrate, Her Lordship (Rtd) Ugonna Ezekwem, made a very salient submission. According to her, we are not lacking laws to ensure the implementation of non-custodial approach, what we lack is the willpower & resources as well as the benefits that will flow. Data has revealed the marginal nature of persons awaiting trial from about 75% in 2015 to 73% in 2023 and a large chunk of the budget goes to feeding the mammoth crowd. Oftentimes, this leads to minor/petty offenders incarcerated ahead of trial coming back to the society more criminal minded than before. Thankfully, with the development of a "Restorative Justice Department" Nigeria has shown eagerness to actualise these recommendations and kick back injustice in the Justice sector.












Virtual Symposium on State Policing; "Enhancing Security and Law Enforcement in Nigeria: Centralised vs **Decentralised Policing Systems."**



LEEN Foundation brought together key stakeholders, policymakers, academics, and members of civil society to engage in a constructive dialogue on its prospective implementation. The Foundation had the renowned Professor Etannibi Alemika talk extensively on "Police & Policing". Interestingly, He opined that due to the fact that State or Decentralised Policing appears "localized", it does not

necessarily mean that the initiative will gain local traction. Other key takeaways from the speakers were on the need for clearly defined duties, sustainable funding models and pilot testing, to effectively actualize the concept. We also had Aisha Abubakar, representing the Executive Director of Partners West Africa (PWAN), Professor Freedom Onuoha and Shaun J. Gavin, a Senior advisor from the US Embassy weigh in their opinions.



This ranged from the quality of constructions done to procurement of materials and a structured spend analysis on the use of the recovered funds.

Quality Assurance visit to Eight (8) States on Administration of Criminal Justice Law (ACJA/L) Compliance Levels

aws protect our general safety, and ensure our rights as Nigerian citizens against abuses by other people, organizations, and the government itself. We have laws to help provide for our general safety, one of such laws is The Administration of Criminal Justice Act, 2015. This merger Act was particularly provided to cushion some of the lapses in the Nigerian criminal justice sector. CLEEN Foundation with support from MacArthur Foundation commenced a project last year about breaking down the provisions of ACJA 2015 to oversight agencies and non-state security actors, to further help them internalize and function in their regions, as a result, the Observatory CSOs across





the selected states were birthed. They have been tasked with advocacy on the provisions of ACJA to the relevant stakeholders and authorities in the States.

To ensure that these groups stay in line with their mandate, our team embarked on a Quality Assurance visit for the

ongoing research on Compliance levels of Actors on the Administration of Criminal Justice Law in focal states. During the visit, the team met with Senior Ibrahim Sulyman Esq, who is the Attorney-General and Commissioner for Justice in Kwara State, as well as Hon Justice Rabi Talatu Umar, who is the Chief Judge, Bauchi State High Court.
